## PROMOTION DETAILS

<b>Promoter</b>	National Gallery of Victoria, (ABN: 77 884 986 472) of 180 St Kilda Road, Melbourne, VIC 3006.
<b>Prize Supplier</b>	National Gallery of Victoria, (ABN: 77 884 986 472) of 180 St Kilda Road, Melbourne, VIC 3006.
<b>Entry Restrictions</b>	Open only to Australian residents who attend the exhibition <i>Riffi: Jean Jullien for Kids</i> at the National Gallery of Victoria during the Competition Period, except directors, officers, management and employees (and the immediate families of directors, officers, management and employees associated with this competition). Entrants must be 18 years of age or over.
<b>Competition Period</b>	10am (AEST) on 1 December 2023 to 5pm (AEST) on 7 April 2024.
<b>Exhibition</b>	<i>Riffi: Jean Jullien for Kids</i> at the National Gallery of Victoria from 3 December 2023 – 7 April 2024 inclusive.
<b>Entry Method</b>	During the Competition Period, entrants must visit the Exhibition, fully complete the Share your thoughts NGV Kids Exhibitions digital survey and provide their email address.
<b>Draw Details</b>	10am (AEST) on 22 April 2024 at the Promoter's office.
<b>Winner Determination</b>	The first valid entry randomly drawn from all valid entries received during the Competition Period will win the prize.
<b>Prize Details</b>	There is 1 prize to be won. The prize consists of the following: (a) Items from the NGV Design Store, as selected by the promoter, valued at up to A\$200.00 (inc GST). The prize must be redeemed within 12 months of the prize draw. All costs and expenses associated with redeeming the prize that are not stated are the responsibility of the winner and their companion.
<b>Prize Pool</b>	The total prize pool is valued at up to \$200.00 (inc GST).
<b>Entry Limits</b>	Entrants may only enter the competition once.
<b>Winner Notification and Publication</b>	The winner will be notified by email within 5 days of the draw.

- 1 Information regarding prizes and how to enter forms part of these conditions. By entering, entrants agree to accept these conditions.
- 2 The competition will be conducted during the Competition Period.
- 3 All valid entries must be received during the Competition Period. Entries are deemed to be received at the time they are received by the Promoter's database and not at the time of submission by the entrant. The Promoter has no control over communications networks and is not liable for any problems associated with them due to traffic congestion, technical malfunction or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred. Entrants who enter using multiple phone numbers or aliases may be disqualified. Automatically generated entries may be disqualified.
